







Green key Global Eco-Label For Tourism Facilities





The Green Key aims to change the practices and behaviour of tourists and related associations including enterprises, authorities, guests and local communities. A major goal of the initiative is to involve these associations in increasing their feelings of responsibility towards the environment on which they depend.

The **Green Key** is an annual award. The philosophy of the program is encouraging environmental education and raising awareness within and around the candidate's facilities and surrounding areas.

Green Key is a voluntary eco-label awarded to more than 2,600 hotels and other establishments in 56 countries.





In Jordan, the demand on limited resources is becoming unmanageable due to increasing development projects, and recently, Immigration and emigration. Therefore, there is an urgent need for an Eco-labelling that has been proven globally to greatly contribute to conserving these resources while ensuring that premises adhere to environmental criteria and are ecologically conscious.

The Royal Marine Conservation Society of Jordan (JREDS) was selected to be the National Representative for the Foundation for Environmental Education (FEE) (non-profit/ governmental organization) to run three of five FEE programs; Green Key for tourism facilities, Blue Flag for beaches, marinas and boats, and Eco Schools.

FEE programs are currently running in more than 72 countries worldwide and are presenting eco-label awards to various facilities.

Green Key is running In Jordan since 2008. Mövenpick Resort & Residences Aqaba is the first Green Key Hotel in the Region





Awarded Hotels In Jordan

Agaba, Amman, Petra and Dead Sea Hotels participated in GK implementation and, since 2009, 19 hotels were awarded the eco-label;

Implementation Procedure

- 1. Fill the Green Key application form.
- 2. Followed by a visit from the Green Key National Operator to firm's management to present the Green Key program in details and discuss the forthcoming steps.
- 3. A "Walk-Through" auditing tour or an "on site" visit to the firm is mandatory to asses the current actual situation and review the main points that need to be addressed in the Green Key action plan.
- 4. Start applying the Jordan National Criteria. A minimum of four months is given for this step. The maximum expected period of time applying for the award depends on the firm/business readiness.
- 5. When the firm/business is ready they will contact the Green Key National Operator to submit their file to The National Green Key Jury. The Jury reviews their request and gives recommendations for Green Key award.
- 6. The International Steering Committee approves the National Jury recommendation.
- 7. The Green Key award ceremony.
